Turning Crisis Into Opportunity What Silicon Valley Can Do To Help Rebuild Japan

A Fundraiser for Orphans of the Earthquake and Tsunami

n Jun. 29, the Keizai Society partnered with two other prominent Silicon Valley business organizations to co-sponsor a fundraiser in support of children who lost their parents in the Tohoku earthquake and tsunami. Keizai's co-sponsors for the event were the technology and business organization representing India (TiE -- The Indus Entrepreneurs) and China (Silicon Valley - China Wireless). The theme of the event was "Turning Crisis Into Opportunity - What SV Can Do To Help Rebuild Japan" and took place at the Palo Alto Research Center.

Hiroshi Inomata, the Japanese Consul General in San Francisco, greeted the crowd with a few words about the crisis to preface the night's discussion. The guest speakers included leaders in diplomacy and government, academia, venture capital, entrepreneurship, sustainability, and philanthropy. The keynotes and panel discussions covered a range of topics. But common to all was the belief that the Japanese people, through resourcefulness and dedication, will apply the latest in technology (IT, materials, sustainability, and

more) to make rebuilt communities even stronger than they were before the devastation.

The first keynote of the night was from **Robert Scoble**, a Technology Evangelist and Managing Director of Rackspace. Robert was introduced by **Scott Ellman**, USAsia Venture Partners and Keizai Advisor, who commented on how traditional Japanese cultural traits of courage and resourcefulness will stand them in good stead in the massive rebuilding effort. Robert talked about creating new infrastructure out of disaster is an opportunity to make things better and how you do this by paying attention to the small things. Specifically he mentioned green technologies used in stadiums, windows, lights, servers and solar panels.

Next was a panel discussion involving Lukas Biewald, the Founder and Chairman of CrowdFlower: Marianna Grossman, Executive Director of Sustainable Silicon Valley; and James Miller, Senior Attorney Advisor at FCC and Adjunct Professor of Law at American University Washington College of Law. Mr. Miller opened the panel with a short discussion of technology and how it

creates better infrastructure including detection, evaluation and notification. He said that Silicon Valley can partner up to develop technologies, especially green power technologies. Mr. Biewald continued the discussion by covering the aggregation of data and crowd sourcing technologies and how they can provide timely and much needed help during disasters. Ms. Grossman finished up by talking about the steps of rebuilding and how to do it sustainably. The host and moderator for the evening was Richard B. Dasher, PhD, Director, US-Asia Technology Management Center, Stanford University.

The final keynote of the day came from Kamran Elahian, Global Entrepreneur, Philanthropist and Venture Capitalist. He strayed off topic and talked about how it didn't matter if Japan was a developing or developed country, the most important thing was helping other people in need. His talk brought home the discussion and made the audience think of concrete steps that they could take now, or in the immediate future to help the people of Japan. He raised \$10,000 in pledges in less than 20 minutes.
